# About ICAI



The Institute of Chartered Accountants of India (ICAI) is a statutory body established under the Chartered Accountants Act, 1949 for regulating the profession of Chartered Accountants in India.

ICAI is world's second largest accountancy body with a strong tradition of service to the public interest and to the Indian economy.

During its more than seventy three years of existence, ICAI has achieved recognition as a premier accounting body not only in the country but also globally, for maintaining highest standards in technical, ethical areas and for sustaining stringent examination and education standards.

### **Central Council**

The affairs of the ICAI are managed by a Council in accordance with the provisions of the Chartered Accountants Act, 1949 and the Chartered Accountants Regulations, 1988.

The Council is composed of 40 members of whom 32 are elected by the members and remaining 8 are nominated by the Central Government generally representing the Comptroller and Auditor General of India, Securities and Exchange Board of India, Ministry of Corporate Affairs, Ministry of Finance , Ministry of Commerce and other stakeholders. In terms of the Act of 1949, the President is the Chief Executive Authority of the Council.

The Secretariat of the ICAI is headed by the Secretary who is incharge of the office of the ICAI as its Executive Head.

The activities of the ICAI can be broadly divided into Regulatory, Disciplinary, Standard Formation and Education & Training.

The Council functions through its 3 Standing Committees and 43 Non-Standing Committees.

The ICAI plays a proactive role to ensure compliance of professional ethics and Code of Conduct in terms of the Chartered Accountants Act, 1949 as well as various pronouncements issued by the Institute.


ICAI not only entertains complaints from Stakeholders/User Groups but also takes *suo moto* action in cases which are brought to its knowledge through external information.



# Financial Reporting Review Board (FRRB)

ICAI established FRRB in 2002 to review Financial Statements.

FRRB reviews compliance with the reporting requirements of various applicable statutes, Accounting Standards and Standards on Auditing issued by the ICAI.





# Peer Review Board (PRB) Constituted In 2002

Objective is the Peer review of audit firms i.e., reviewing the quality control framework of the Practice Units (PUs) in performing assurance engagements.

More than 1000 Practice Units apply for Peer Review every year. Total number of Peer Review Certificates issued till 22.02.2023 are 14672.

The Council may nominate members to the Board from outside bodies and from a mongst prominent individuals of high integrity and reputation, including but not limited to regulatory authorities, bankers, academicians, economists, legal professionals and business executives.

Sub Committee of PRB orders a follow on review of those firms whose reports are qualified and withholds the issuance of the Peer Review certificate.

SEBI has made it mandatory for the listed entities, that limited review / statutory audit reports submitted to the concerned stock exchanges shall be given only by those auditors who hold a valid Peer Review certificate.

As a result of this, the firms not peer reviewed are not eligible to conduct audit of Listed entities.

The Comptroller & Auditor General of India has recently revised the Policy of Empanelment of CA Firms/LLPs and appointment of auditors of Companies and of Statutory Corporations/Autonomous Bodies as per the provisions of their respective Acts. A maximum of 25 points have been allotted to firms which hold Peer Review Certificate on the date of making an application for empanelment.
